OAKLAND, CALIFORNIA**

Services Required: The City of Oakland (City) is soliciting proposals from qualified firms for services related to providing private armed foot and bicycle patrols in Oakland, California. The Firm ultimately selected will be a visual deterrent to crime, support the Oakland Police Department's (OPD) efforts to reduce the reality and perception of crime, and be an immediate resource to the business communities being served. The Agency plans to select one highly qualified Firm to perform the required services. The foot and bicycle patrols will be conducted within the boundaries of the Central City East (CCE) and Coliseum Redevelopment Project areas.

The Agency intends to enter into a contract with one security firm ("Firm") to provide armed patrol services. The contract will be valid for eighteen months, on a time and materials basis, in an amount not-to-exceed \$180,000. The contract may be extended for one year upon approval of both parties. The selected Firm may be assigned to specific commercial corridors at the discretion of the Oakland Police Department ("OPD") and the Agency.
